NOTICE REGARDING USE OF THE JOHNNY MERCER PAPERS AND THE JOHNNY AND GINGER MERCER PAPERS

The Johnny Mercer Papers (M81-1) and the Johnny and Ginger Mercer papers (M95-15) held by the Special Collections Department of Pullen Library at Georgia State University are open for study, inspection, and research use to all who wish to use them. In accordance with the policies of the Special Collections Department, photocopying and audio-visual duplication services are available for the purpose of supporting private research and study. The Department reserves the right to refuse copying requests because of the physical condition of the materials, copyright laws, or other concerns. It is expected that all patrons will comply with federal guidelines regarding copyright and fair use. A few specific restrictions apply to certain uses of materials in the collection, and these are outlined below.

Use of lyrics, songs and scripts (draft, published or unpublished) contained in the collections:

Users of the collection may not use lyrics, songs or scripts from the collection for the purpose of publishing, re-publishing, performing, or recording them, with or without existing or newly-composed music or lyrics, without the express written permission of the Special Collections Department and all other copyright holders. *Photocopying of lyrics, songs and scripts is not permitted except in connection with academic projects; the requestor must provide a written description or proposal for his or her project and receive permission from the Special Collections Department before copies will be made.*

Use of the Mercer autobiography: The Mercer autobiography (a copy of which is contained in the collection) may be used and quoted for the purposes of research, education and historical investigation. Publication or dissemination of the entire autobiography, or extensive portions of it (in excess of three pages), however, requires permission of the Special Collections Department. *Photocopying of portions of the autobiography is not permitted except in connection with academic projects. A maximum page limit of 10 pages of photocopying applies, unless the requestor provides a written description or proposal for his or her project and receives permission from the Special Collections Department to receive additional copies.*

Use of audio-visual materials (including photographs, audio and moving image recordings): Audio-visual materials may be used for research and may also be used as supporting materials for published works, documentaries, and exhibits, within the guidelines provided by copyright law in the United States. The requestor bears responsibility for clearing any rights that may apply to such materials.

Commercial use: Materials in the collection, including the autobiography and other manuscripts, photographs, artifacts, and audio and moving image recordings, may not be used for the creation of postcards, mugs, t-shirts, phonograph recordings or other saleable merchandise, or for public performances, without the express written permission of the Special Collections Department. Johnny Mercer=s likeness and image may not be used for commercial purposes. All applicable guidelines provided by copyright law in the United States must be observed in all cases, and the requestor bears responsibility for clearing any rights that may apply to the materials requested for use.
